First Section Introduction

"Despite the occurrence of challenges, achievements for the nation can be realized." These words were mentioned in the introduction to Madayn's Annual Report 2019, and we reaffirm our full commitment to all these pillars in Madayn's Annual Report 2020, as long as the beloved homeland is the ultimate goal, thus, all difficulties and challenges will not be an obstacle to a national institution that was established by Omani cadres, and has made great achievements in the modern renaissance of Oman. National cadres who have been true to their covenant with the Almighty Allah and the wise and enlightened leader of the victorious march, His Majesty Sultan Haitham bin Tarik - May Allah protect and preserve him – they pledge loyalty and to be up to the highest degree of honesty and responsibility in contributing to comprehensive and sustainable economic and social development all over the nation, following the slogan "Oman, present and future, unlimited renewed renaissance".

Madayn's Annual Report 2020, records the end of Madayn's Plan 2020 and assesses its results, and Madayn's Vision 2040, and goals that Madayn aspires to achieve. Considering the outcomes of the plan 2011-2020 and the indicators that Madayn aims to achieve in 2040, we note the achievement and ambition, an achievement that was achieved as a result of plans, programs and policies, strategic plans emanating from Madayn's national goals, which was included in the institution's system (law) accompanying the Royal Decree No. 32/2015, which stated, "The institution aims to contribute to the holistic and sustainable economic and social development through the effective management of the related estates", and the ambition based on a vision that emerged from the National Vision "Oman Vision 2040",

which included specific national priorities and goals, and developed measurable policies, programs, and projects with specific digital indicators.

Throughout its 2011-2020 plan, Madayn has recorded positive growth indicators, as a growth rate of (73%) in investments volume indicator, (80%) in the number of projects indicator, and (67%) in the workforce indicator, which is considered as good outcomes in the field of planning, particularly when setting ambitious indicators that presents several challenges to accomplish. Bearing in mind the variables and circumstances that occurred during the implementation of plans and programs, and changes and challenges posed by that exceptional circumstance, which was not taken into account while developing the results indicators of workplans and programs. It is worth noting the catastrophe that befell the whole world during the 2019 and 2020 years of the plan's life. This has coupled with what is faced by the global market in relation to the drop in oil prices, which has eventually developed repercussions that have negatively affected the entire economic sectors during the years 2017, 2018 in particular. In other words, four years had negative repercussions on all sectors, not only at the local level but also at the regional and global levels. That is, 40% of the plan period went through exceptional circumstances that ravaged the financial and business sectors. Therefore, the results achieved by Madayn are more than good. This report shows in detail the percentages of achievements that have been achieved from Madayn's Plan 2011-2020.

The year 2020 witnessed isolation imposed on individuals and countries, and in light of that isolation, border crossings were closed and travel was banned, which resulted in losses in production and jobs in all countries and regions of the world without exception. Despite all these circumstances, Madayn was able to maintain the volume of its

investments and achieve a small growth rate, but it is considered a significant achievement under these exceptional circumstances. Whereas, the growth rate has reached 1.8%, which is the lowest in the past ten years. In terms of workforce, despite the decline in the total number, certain progress was observed in the employment status of Omanis by up to 3%. Compared to the national indicators, we find that Madayn has succeeded in reducing the negative effects in a very large way, as a result of a set of measures and facilities that have been taken by Madayn promptly. Despite all these repercussions, "Madayn" continued its strategic efforts towards attracting more investments and providing an appropriate investment environment by facilitating investment procedures and opening new branches of "Massar" in industrial cities.

In 2040, through the implementation of programs and projects that have been driven from the national priorities and goals of Oman Vision 2040, Madayn intends to achieve (RO 15 billion) in investment volume - (10,000) in the number of projects indicator, and (270,000) in the number of direct and indirect job opportunities. Madayn is also seeking to raise the workforce's share of the total jobs by (50%) and to raise the number of factories to (6,500) factories. For the first time, the added value of Madaen will be measured on the different economic sectors.

Before starting to read our report, we would like to point out that Madayn has appointed a specialized consultancy firm to survey all its affiliated cities, to ensure the integrity of its statistical data, as most of this data is based on data and information collected from operating companies, and are subject error. Whereas the specialized consultancy firm concluded computability of our figures. The scope of work has also been expanded to include many indicators.

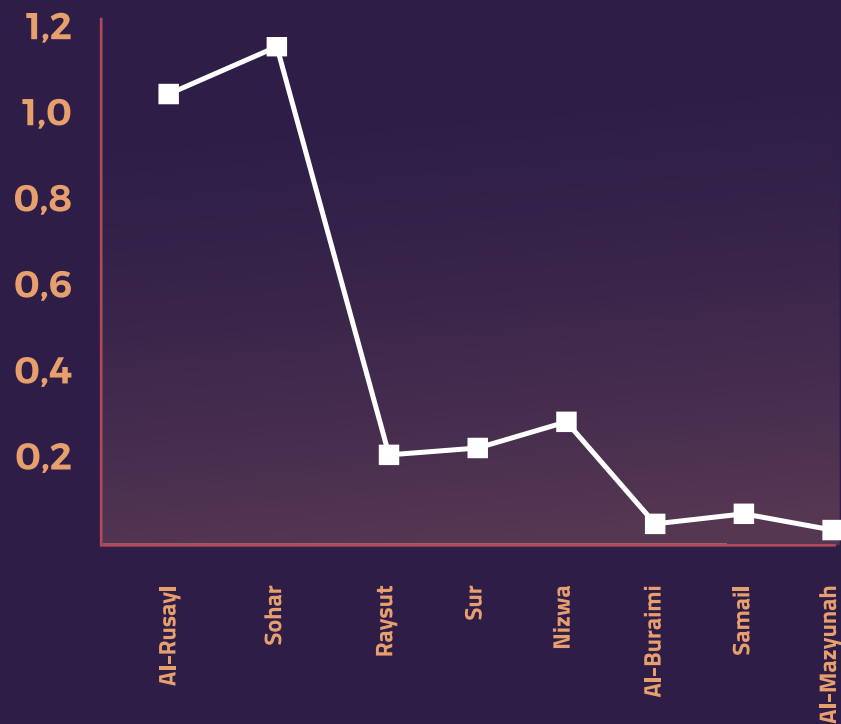
As part of the introduction to this annual report, we would like to

indicate that the industrial survey carried out by "Madayn" showed that the companies operating in "Madayn" have contributed with an amount of RO 2,805 billion of the total GDP, which amounted to RO 29,349 billion during the year 2019. In addition, the value of these companies' exports amounted to RO 1.36 billion during the same year. Thus, these companies also contributed with a local added value of RO 1.99 billion during the year 2019, therefore, all these indicators confirm the vitality of this sector. Thus, "Madayn" further confirms that every effort shall be made to support and develop this sector and harness all available capabilities to promote

This report reviews the digital indicators and works achieved by "Madayn" during the year 2020, as well as reviewing its five-year strategic plan for the next phase. This report also confirms to everyone that "Madayn" provides an ideal environment for investment and continues to raise its contribution to sustainable economic and social development, and that it has the efficiency and flexibility that enables it to deal and manage fluctuations and variables to meet the requirements of the growth and prosperity of the industrial sector and achieve its mission and vision.

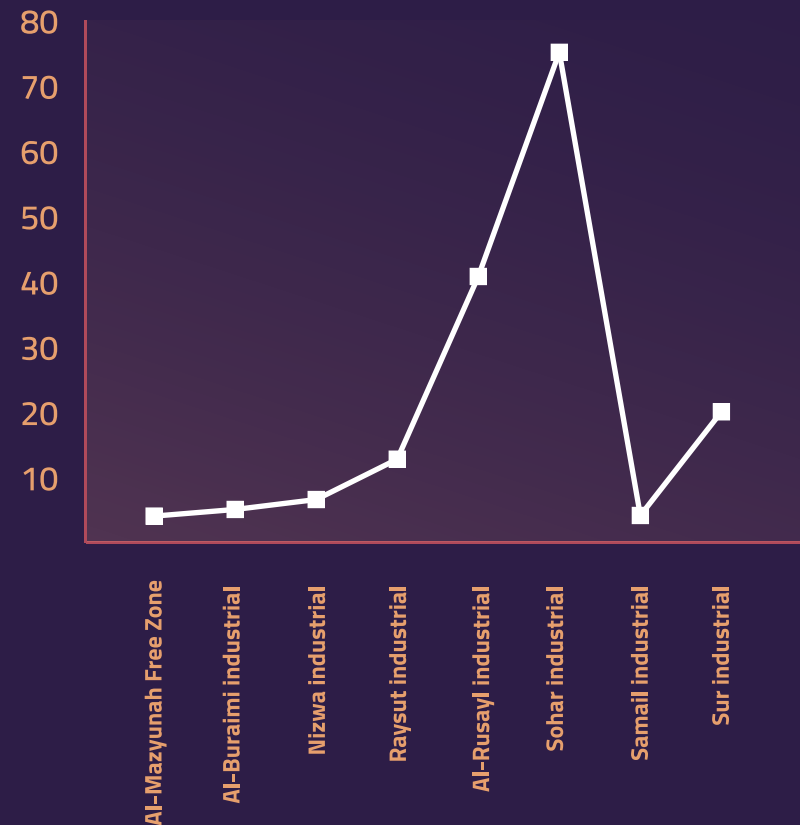
Industrial Survey Results 2019

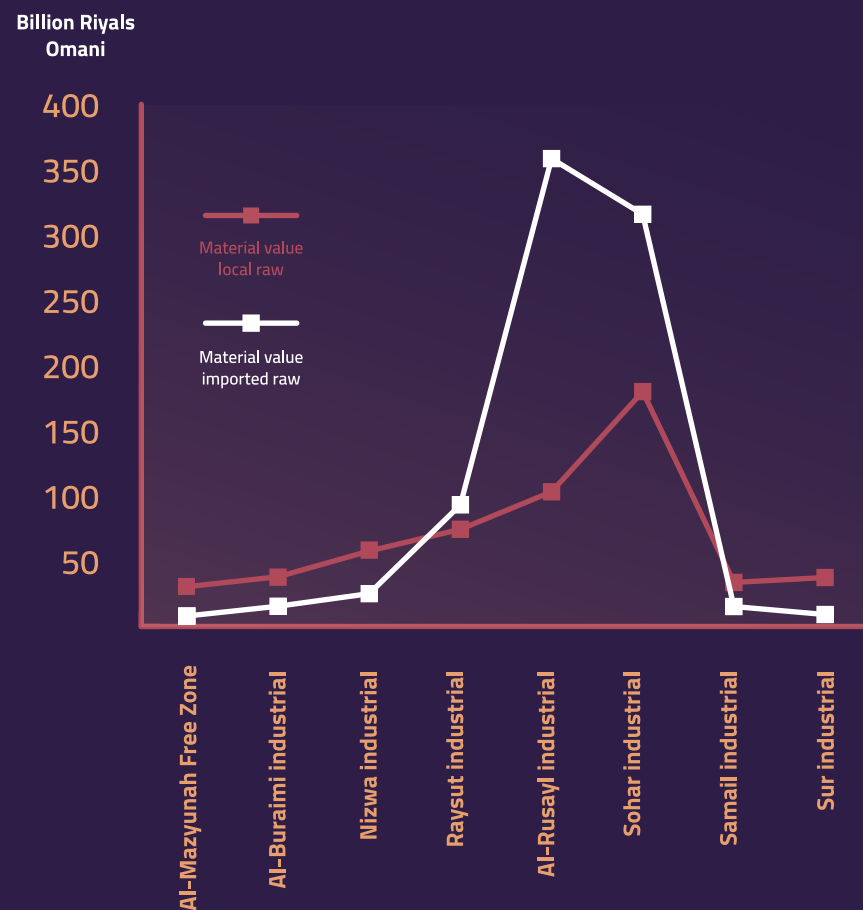


Distribution of Gross Product by Industrial Cities

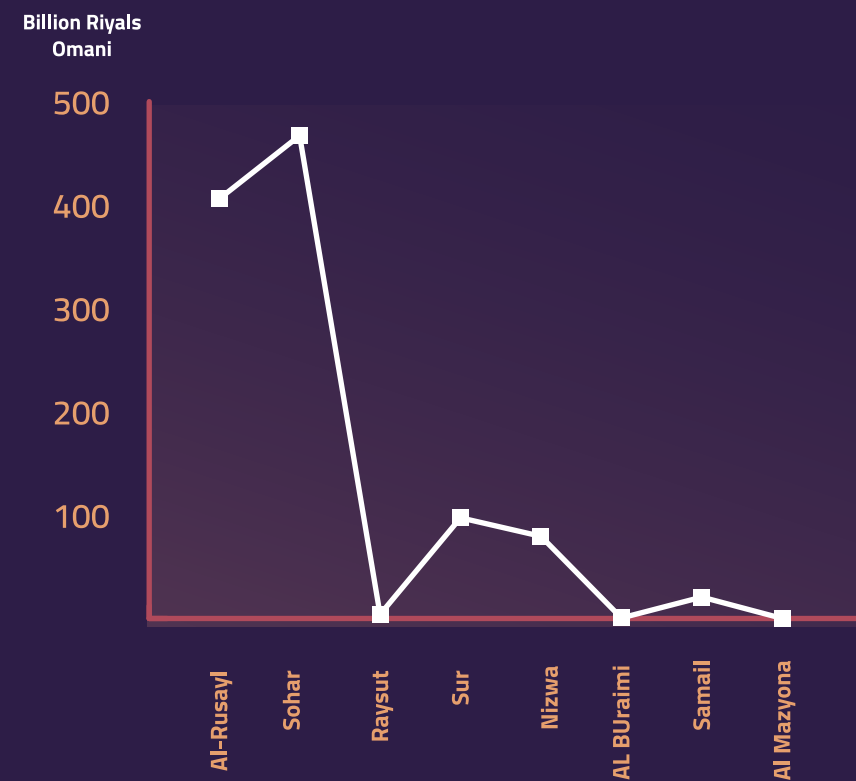

Unusual Year

During the past year, all mankind has been affected by the exceptional year that passed by us, and Madayn is not an exception. It was a year that changed life and human behaviour, in which airports were closed and travel restrictions were placed, a year that left its mark on all aspects of the human experience. In a year that saw unprecedented closures, 2020 will be remembered as the year of the repercussions of Covid 19. As is the case in every aspect of life, the effect on the entire economy was negative. In Madayn we have experienced the repercussions of this pandemic, and we pray that all of humanity be spared its effects.

Consequently, in order to be able to convince companies to invest in industrial cities, and to attract new investments, it is important to reduce as much negative impact as possible on them. In an effort to minimize Covid 19's repercussions on existing companies and to increase investment in its business cities throughout the Sultanate, Madayn has taken a number of measures designed to increase investment. We provided financial and exemption packages to operating companies as well as exemption packages to industry-related cities and activities. Additionally, we worked with all entities operating in the country to ensure a continuous flow of production from factories and companies operating within them. Despite this exceptional year, Madayn was able to increase its investments volume by approximately 1.8%. It also recorded an increase of 4 % in the number of the national manpower in the field of manpower despite the closure of airports and the restrictions on travel which were imposed in various countries of the world, including the Sultanate.

Madayn plan 2011-2020 reached its harvest year in 2020. Even with the geopolitical conditions, financial crises, and low oil prices of the last couple of years, including a devastating pandemic of Covid-19 that affected all sectors and all businesses, Madayn managed to reach good achievement rates with its main target indicators. The volume of investments index achieved a 73% completion rate this year, the number of projects indicator achieved an 80% completion rate, and the labour force index achieved a 66% completion rate.

As a final word I would like to express my gratitude to the entire staff of the Public Establishment for Industrial Estates-Madayn at their various locations for their generous contributions and sincere work that led to these tangible achievements. We still have more to do, so that we can contribute to the elevation and progress of our dear Oman under the leadership of His Majesty Sultan Haitham bin Tariq, may God protect and preserve him.

A Distinct Strategy Policies

Rules, procedures, and legislative frameworks will be developed to regulate how to attract local and foreign industrial developers to invest in creating, managing, and operating specialized investment zones and their operations.

The Usufruct and Investment Agreements with developers will be effective for a period of up to ninety-nine years based on the project.

Foreign and regional experts in creating, managing, and operating industrial cities will be attracted and hired in accordance with management and operation agreements of up to **25** years.

The full authority will be delegated to the management of the industrial cities in all governorates to approve investment applications of industrial zones of up to **100,000** square meters.

The regulations provide that the investors' applications will be decided on within a period of no later than ten days.


The investment applicants will sign contracts and complete the procedures for investing in Madayn's industrial cities within thirty days from the date of approval.

No investment activity will be only allowed in the industrial cities unless a license for investment activity is obtained and such license can be renewed on annual basis. Such license will be only granted or renewed for investors who meet the legally defined requirements, and the most important of these requirements is to achieve Omanisation rate in their ongoing projects.

The rights and obligations of the investors as well as the obligations of Madayn to the investors have been clearly defined.

The license for investment activity will only be canceled or suspended in certain and limited circumstances and in a way that serves the interests of investors and does not disturb their business operations.

To ensure Madayn's commitment to the development and use of best management practices in providing its services, the investment regulations have set the dates and periods for granting approvals and licenses.




The lease contracts with the investors will be effective for a period of thirty years and can be renewed for a similar period.

To reduce the shadow ventures and not to allow any business activities that are against the applicable laws and regulations restrictions have been placed on sub-leasing contracts and no license holder will be allowed to engage in any activity in the industrial cities.

The investment regulations included clear procedures on how to deal with the buildings and facilities built by the investors and developers upon the expiration of their contracts in a way that will protect their rights and third-party rights.

In the case of default and failure to complete projects under exceptional circumstances, the investors and developers may sell buildings and facilities that existed on the leased lands according to well-defined procedures provided that such sale is made to investors who hold licenses for the same activities intended for such lands and facilities.



The work of contractors and suppliers in the industrial cities will be regulated and their relationship with the investors will be supervised in a way that will protect their rights and the investors' rights. The investment regulations have established clear restrictions and requirements for construction work in these cities and have set a period for receiving a reply from the relevant bodies. The problem of buildings, equipment, and goods that existed in the lands upon the expiration of the contracts for any reason whatsoever will also be resolved by establishing restrictions for auction sale and all its aspects.

The relationship among investors, goods transporters, and transport intermediaries will be regulated and periods for providing services to investors will be set. No empty means of transport will enter the industrial cities without a permit and an application submitted by an investor operating in these cities.

The relationship of staff of the investors will particularly be regulated in a way that protects their rights and the rights of investors. Staff accommodation restrictions and requirements will be established to ensure meeting the basic humanitarian needs in accordance with the best relevant standards and requirements.

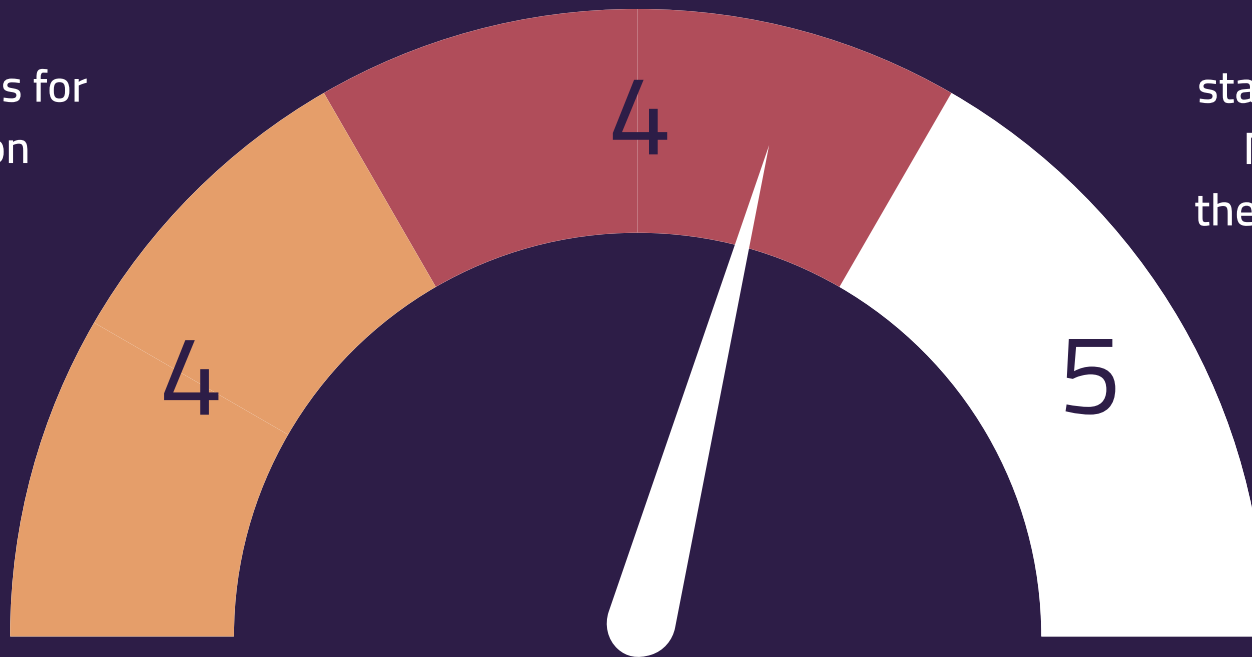

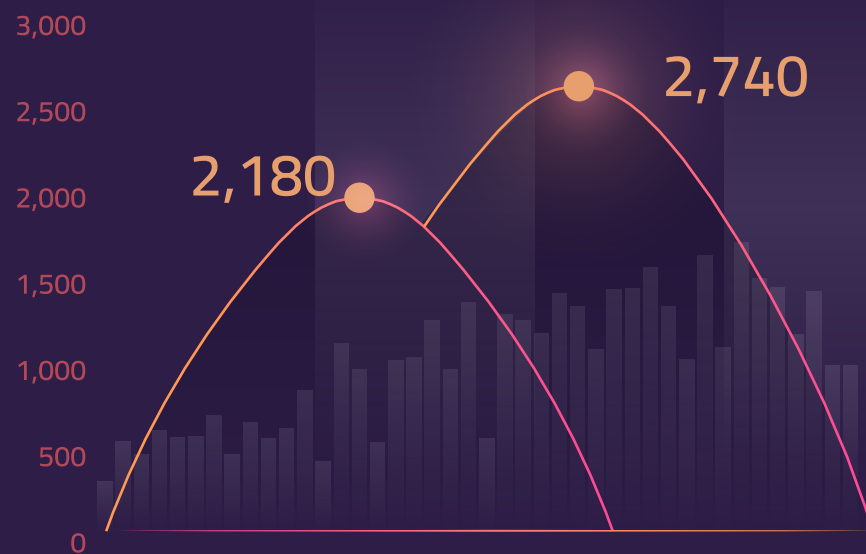

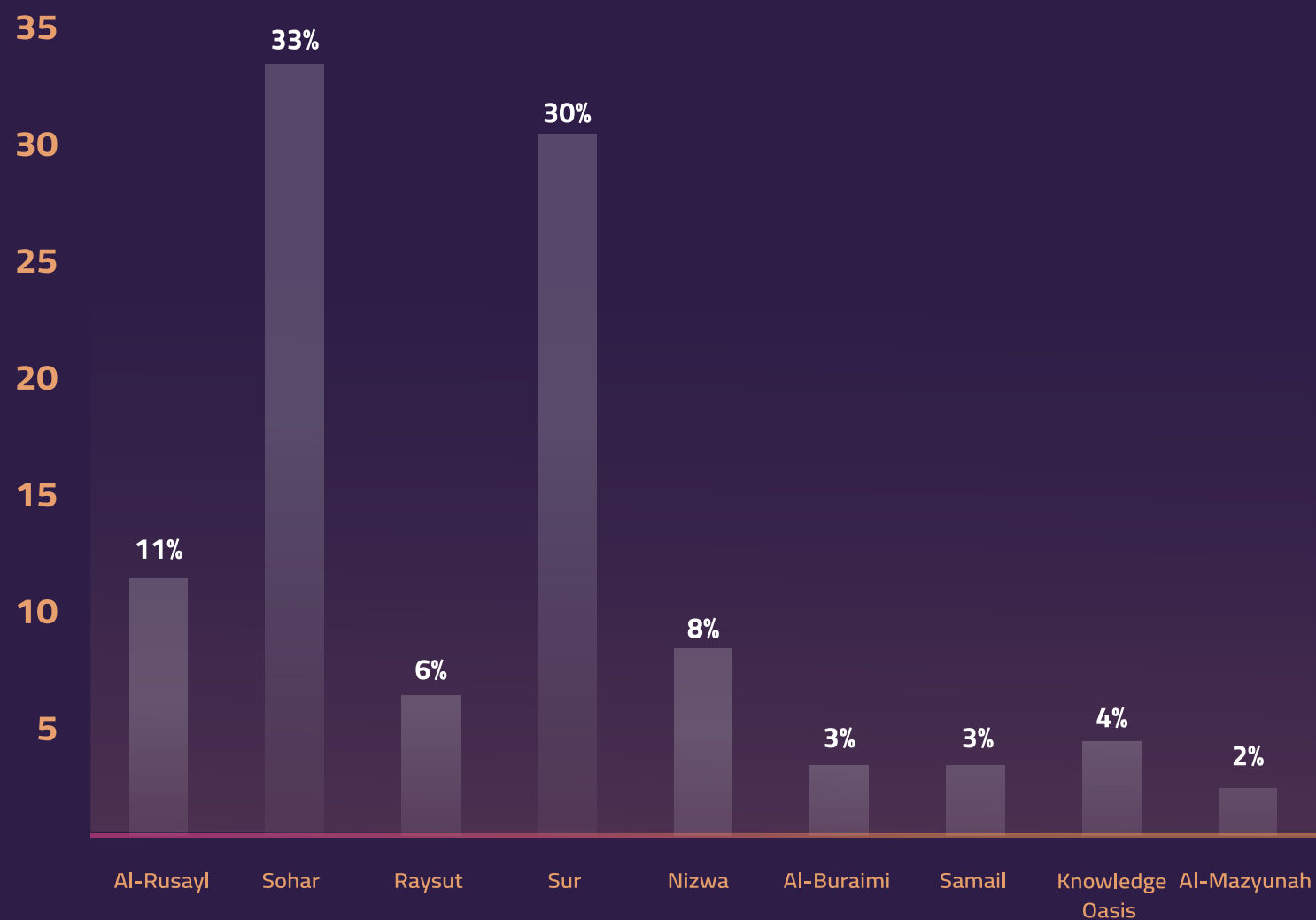

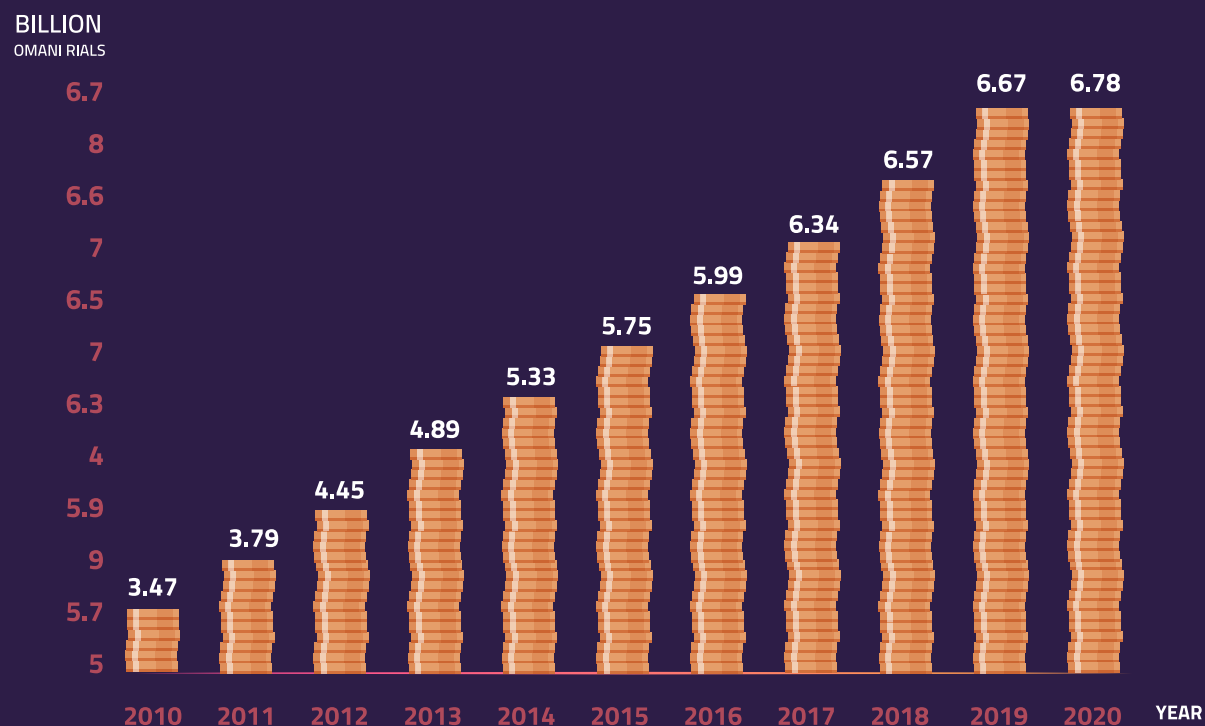
The total investments at the end of 2020 compared to the investments at the end of 2019

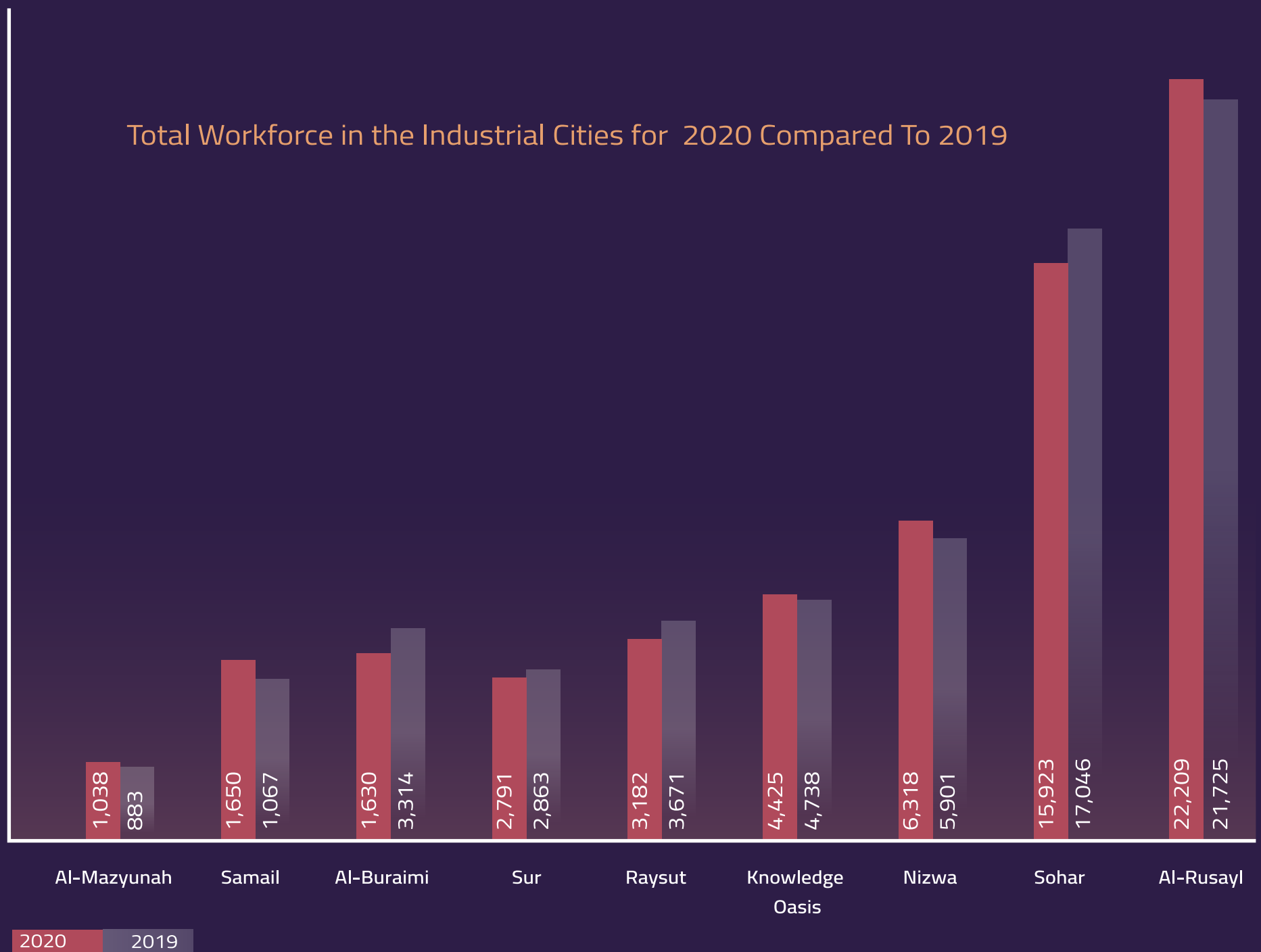

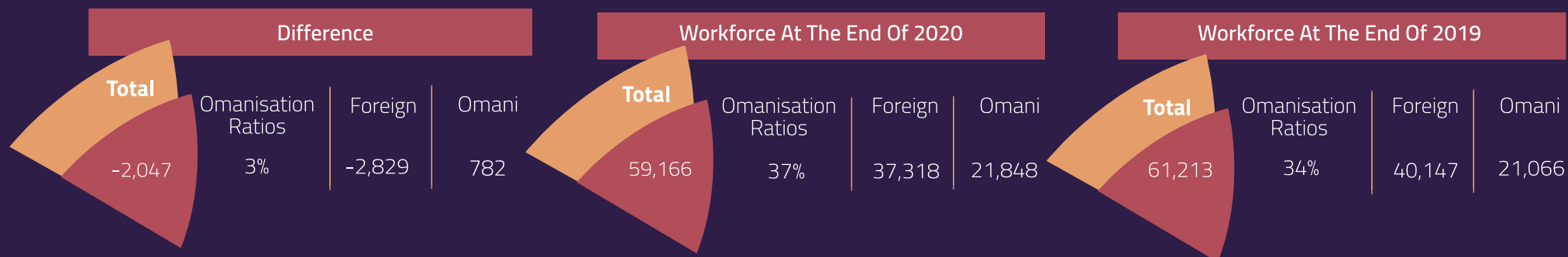

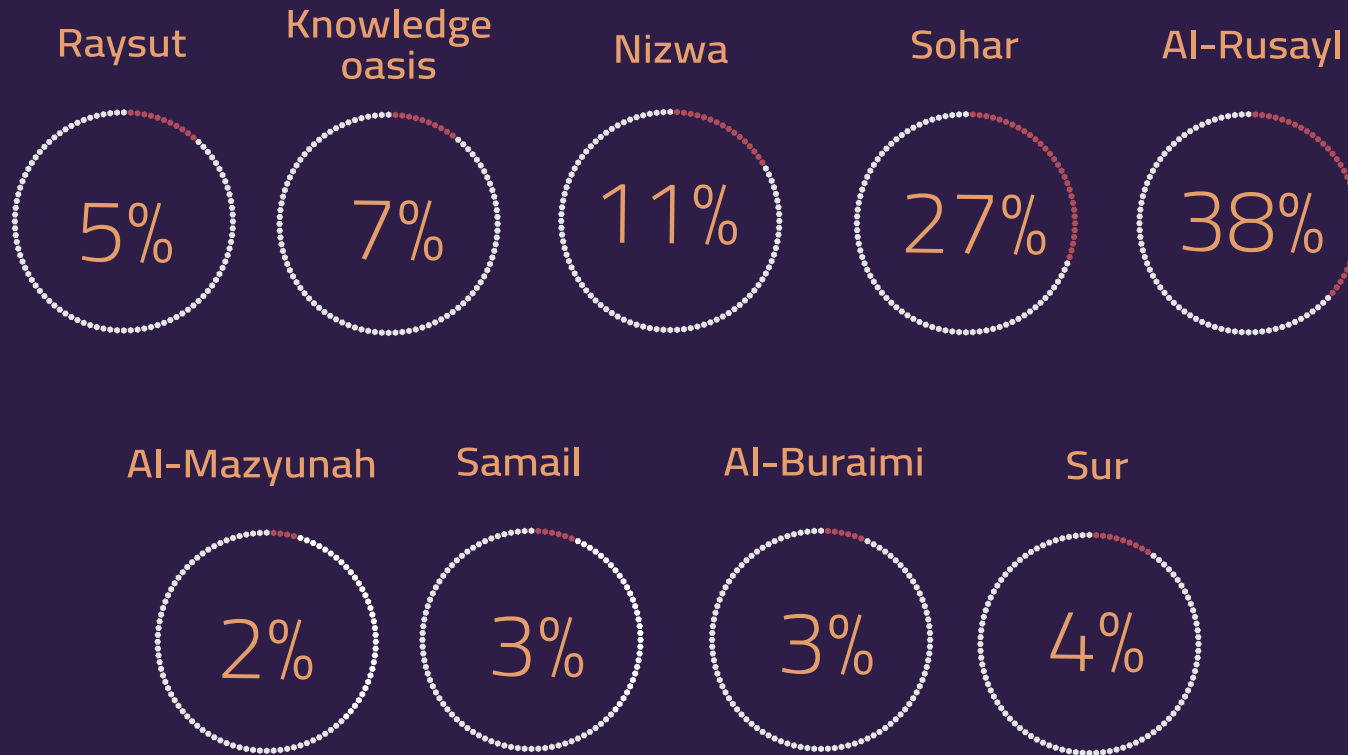

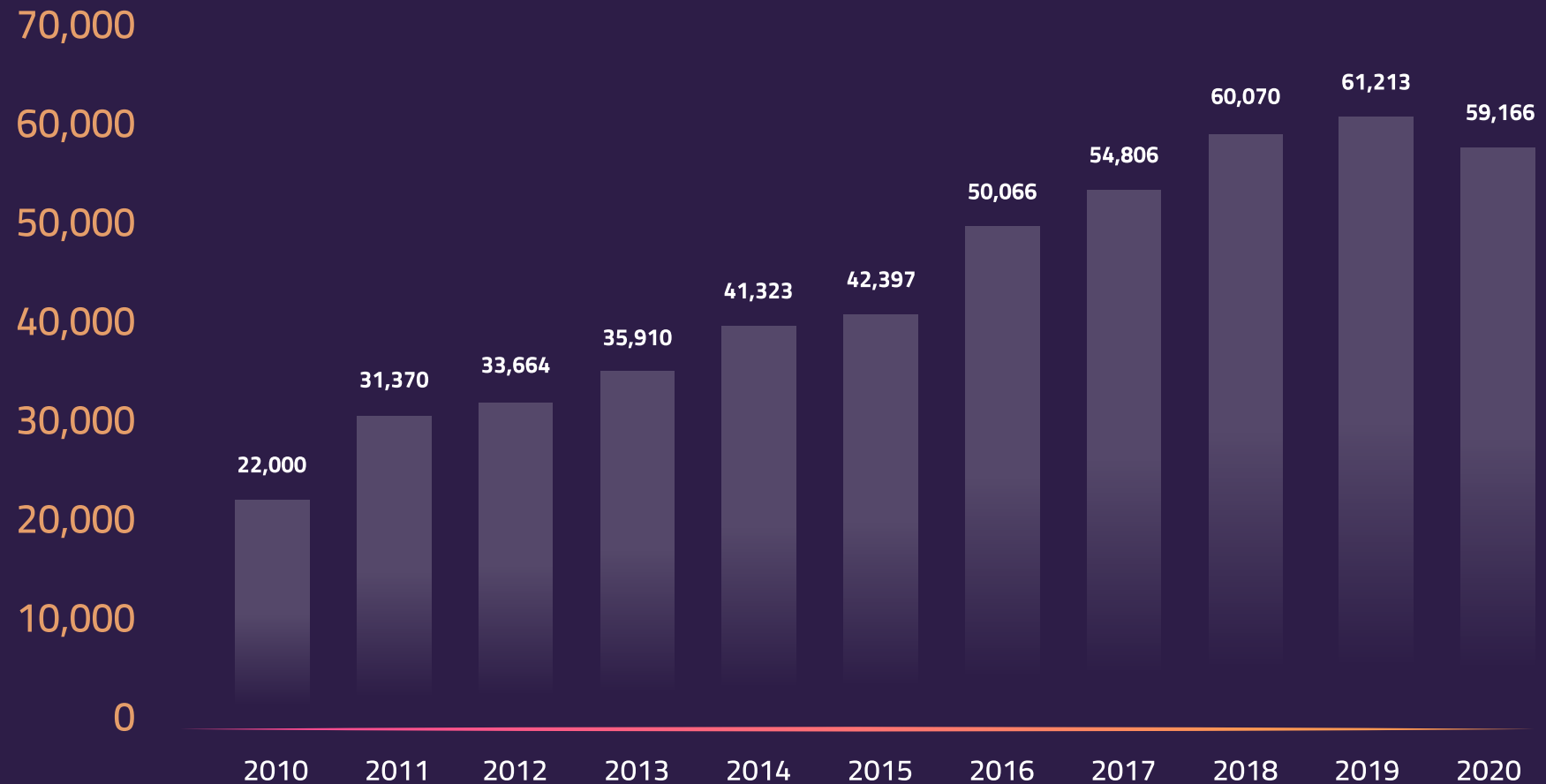

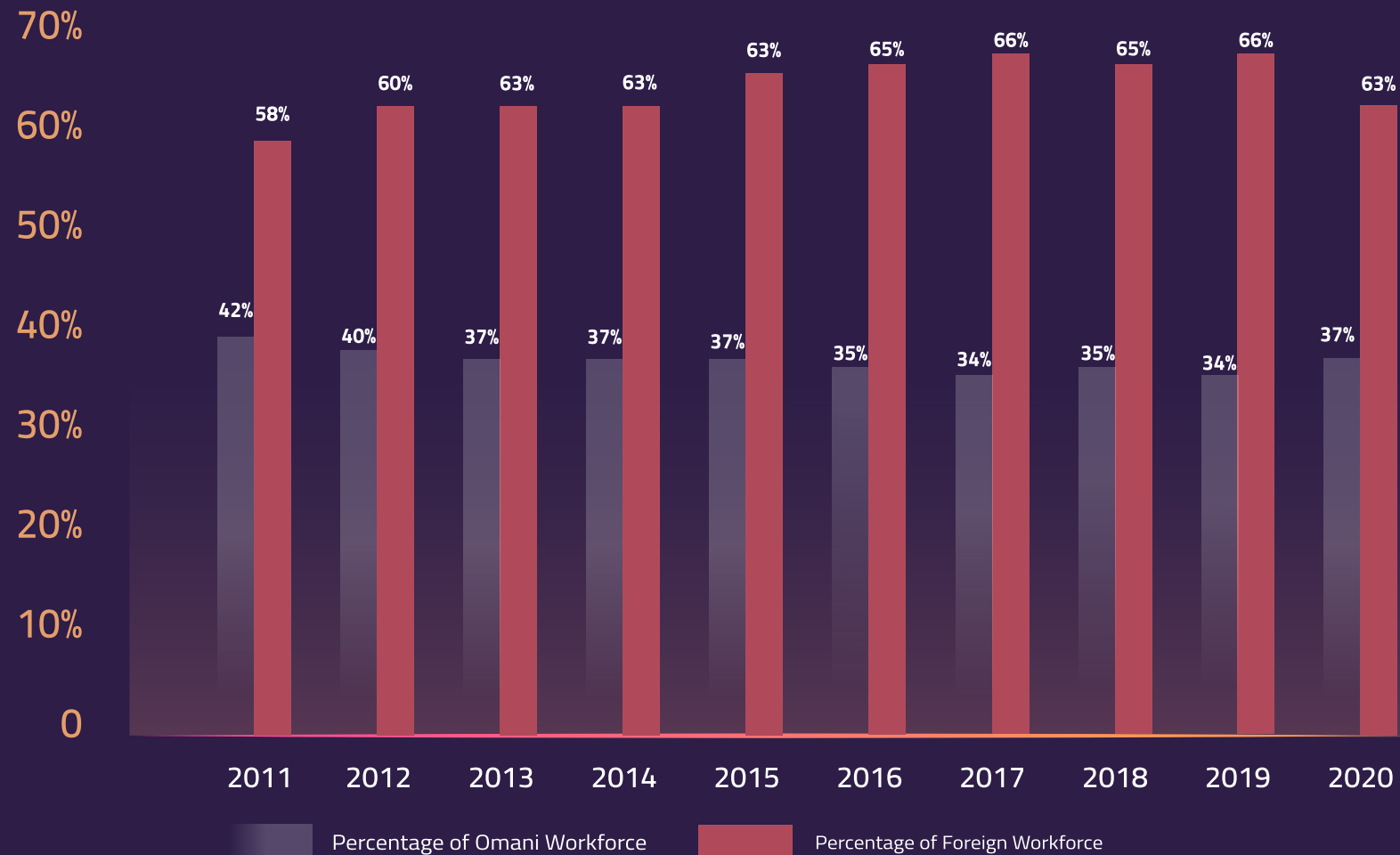

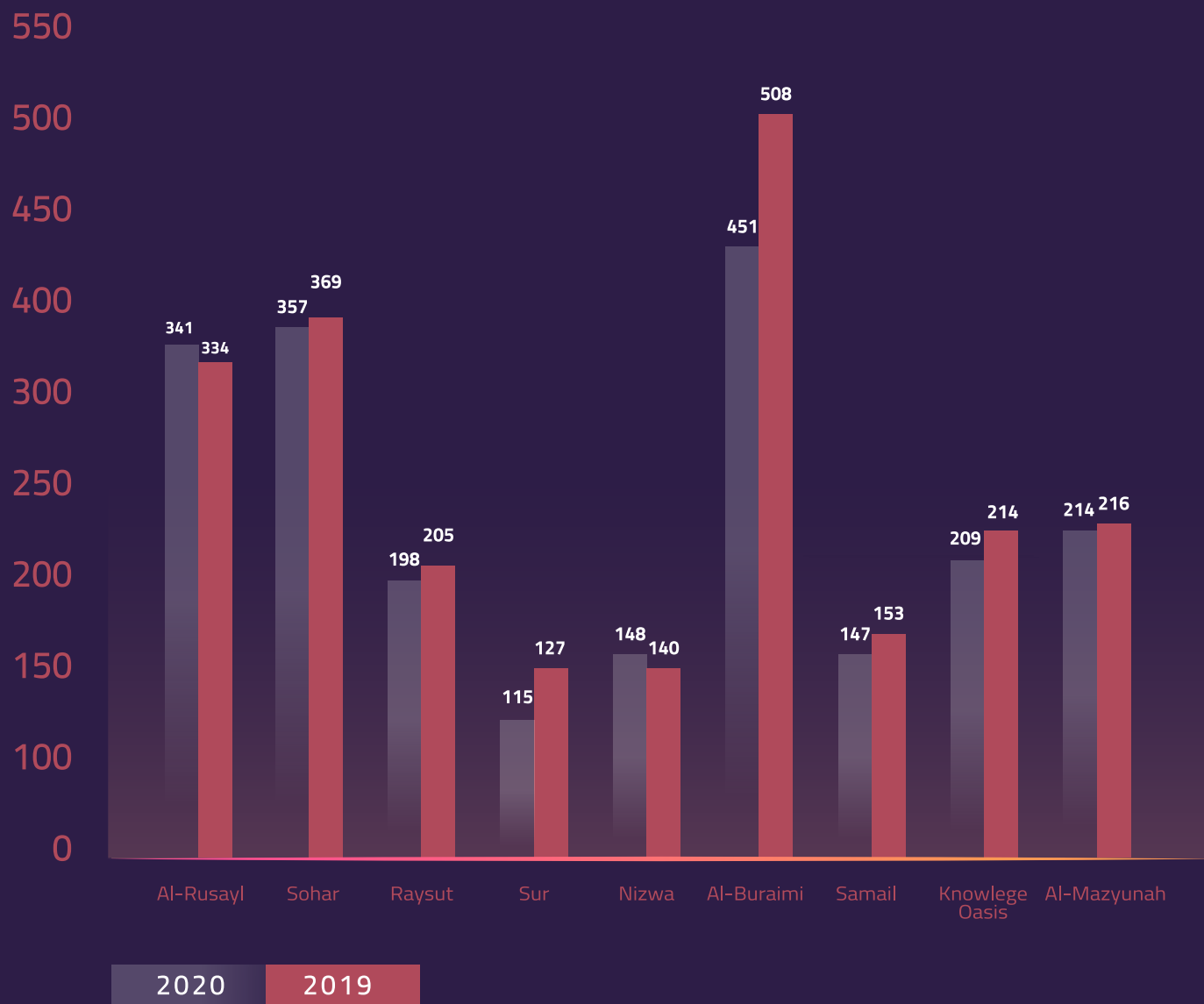

- △ To be granted developed plots of lands with full utilities (water, electricity, gas, telecom, sewage system).
- △ To have transparent legal frameworks for rights and obligations.
- △ To be provided with the services within the specified periods .
- △ To participate in the international and local exhibitions organized within the 'Made in Oman' campaign.
- △ To participate in all workshops, seminars, and exhibitions organized by Madayn
- △ To have access to integrated residential cities.
- △ To receive support from the government agencies through Masar.
- △ To have access to investment cities where separate legislation and regulations are applied.
- △ To be exempted from the income tax for the first five years of the industrial project period.
- △ To be exempted from the taxes and the customs duties on production.
- △ To have a 50% reduction of the fees for issuance and renewal of environmental permits in certain activities.
- △ To engage into certain industrial activities without an environmental study.
- △ To have access to a well-prepared infrastructure.
- △ To invest in industrial cities situated close to roads, ports, airports (Logistics)
